From Arc of PA: The Arc of Pennsylvania Report to State Task Force November 3, 2021

Special Education Services in Pennsylvania

The following is taken from written testimony by Sherri Landis (Executive Director, The Arc of Pennsylvania) to the Commonwealth of Pennsylvania / House Education Committee on October 6, 2021.

"Special Education Services in Pennsylvania is at a crucial point, Pennsylvania led the Nation in providing a public education to students with disabilities following PARC consent decree in 1971; however, school districts struggle to provide students with IDD the essential supports and services they are entitled to under the Individual with Disabilities Act (IDEA) due to historic under funding at both the Federal and State level. The outbreak of the COVID-19 pandemic and the shift to virtual learning has also significantly impacted the education of students with IDD. Students with IDD face great challenges in this time of online learning as many of the supports and services they need to access learning and receive a free, appropriate public education (FAPE) do not readily adjust to a remote learning format."

"For the state, and school districts, to ensure that students with IDD receive the fullest educational supports and services possible, The Arc of Pennsylvania make the following recommendations for reform:

- In part, prioritize an inclusive educational experience for students with IDD.
- Support school districts in the recruitment and retention of qualified staff such as special education teachers, paraprofessionals, educational assistants, etc. – who support students with IDD in the classroom
- Promote better coordination and access to vocational education for students with more complex needs.
- Shift the Burden of Proof to school districts in a Special Education Due Process Hearing.
- Apply the Special Education Funding Formula to charter schools.

Disability Employment Awareness Month

On September 21, 2021, Governor Tom Wolf issued a Proclamation establishing October 2021 as Disability Employment Awareness Month. In such Proclamation, Governor Wolf declared that "all Pennsylvanians should have the opportunity to live and work with dignity, freedom, and economic self-sufficiency. Workplaces that welcome the talents of all people, including people with disabilities, are a critical part of our efforts to build an inclusive community and a strong economy; ..." Taken "in part" from the "Disability Employment Awareness Month" Proclamation.

Helping Teens with disabilities prevent and treat depression, anxiety

"Teens with disabilities are up to five times more likely to suffer from mental, emotional and behavioral health disorders than adolescents without disabilities, University of Illinois Chicago researchers say, and care coordination services help these young people get the medical care and social services they need to be healthy. However, current care coordination programs usually do not provide mental health treatment or offer preventive mental health interventions." Now, researchers at UIC have been awarded \$7 million from the Patient-Centered Outcomes Research Institute to assess whether integrated behavioral health care coordination, which includes a tailored mental health treatment component, achieve better outcomes than a standard state agency care coordination program."

Education Law Center of Pennsylvania

The Education Law Center of Pennsylvania, Public Interest Law Center, and the law firm O'Melveny have joined together to file a lawsuit on behalf of school districts, parents, and two statewide organizations against legislative leaders, state education officials, and the governor. This group is asking for a court order that will force the legislators to comply with the state constitution and ensure that all students receive access to a high-quality public education. ¹ elc-pa.org

"The case initially filed in 2014 on behalf of parents, school districts and statewide organizations in response to the failure of Pennsylvania's legislature to adequately and equitably fund public education, was remanded to Commonwealth Court in September 2017 by the State Supreme Court, which ruled that the claims in our care are subject to judicial review. ² elc-pa.org

Commonwealth Court Judge Renee Cohn Jubelirer has scheduled a trial start date of November 12, 2021. Attorneys expect the trial in Harrisburg to run through December. From elc-pa.org

The Arc of Iowa V Reynolds Lawsuit / Mask

Eleven parents of children with disabilities and lowa's disability groups have filed a federal lawsuit challenging an lowa law that bans schools from imposing mask mandates in schools. Earlier this year, the lowa legislature passed House File 847. It would prevent local school districts from requiring anyone to wear a face mask and it was signed into law by Governor Kim Reynolds.

On September 13, 2021, Robert W. Pratt, Judge / U.S. District Court ordered that:

- 1. Defendants; Governor Reynolds, Director Lebo, and the school districts, are ENJOINED from enforcing lowa Code section 280.31 banning local public-school districts from utilizing their discretion to mandate masks for students, staff, teachers and visitors.
- 2. Notwithstanding the provisions of Rule 65 (C), the court finds this Temporary Restraining Order shall issue immediately, without bond or security, in light of the nature of the conduct temporarily enjoined, and the fact that Defendants will not suffer any costs or damages in the event that the Court determines that the Defendants were wrongfully restrained.
- 3. The Temporary Restraining Order shall remain in full force and effect until the court enters an Order of Plaintiff's request for a preliminary injunction. If the parties desire to have an additional hearing on the matter after briefing the request for a preliminary injunction, counsel shall confer and contact Chambers with a proposed hearing date.
- 4. The court is entering this order to prevent further injury, and loss to plaintiffs."

Pennsylvania General Assembly

House Bill 85

This bill would require our post-secondary colleges to adopt policies that would allow existing documentation in the IEP, 504 Plan or a record of disability from another institution of higher education, or documentation from the military to be accepted as a proof of a disability. House Bill 85 remains in the House Education Committee.

House Bill 250

This bill expresses the desire of its sponsors that the Department of Education create curriculum for Health Classes that will provide a framework for positive discussion and increased understanding. House bill 250 remains in the House Education Committee.

House Bill 272

This bill proposes to address the following issues related to Pennsylvania's Charter School Law:

- Right to know
- Protecting your property tax dollars
- Protecting the future of our kids

House Bill 272 remains in the House Education Committee.

House Bill 365

House Bill 365 would update language in the PA School Code to remove derogatory language in refencing to students with intellectual and developmental disabilities. House Bill 365 was voted favorably out of the Senate Education Committee and is eligible to be brought before the full senate for a vote.

House Bill 458

This Legislation is designed to provide that, in the event of a residency dispute between school districts, a school district would not be permitted to remove a child from school until the dispute has been fully resolved and it has been determined which school district should correctly enroll the child. House Bill 458 remains in the House Education Committee.

House Bill 540

House Bill 540 would implement the Special Education Funding Commission's recommendation to "apply the same funding principles used in the formula for school districts to determine a school district's payment for a special education student enrolled in a charter or cyber charter school....". House Bill 458 remains in the House Education Committee on April 9, 2021.

Senate Bill 542

Senate Bill 542 would remove the across-the-board assumption of a 16% special education population rate per school district to using the school district's actual percentage of special education population. Senate Bill 542 was referred to the Senate Education Committee on April 9, and remains in that status.

Senate Bill 664

SB 664 enables students with IDD who turned 21 and graduated at the end of the 2020-21 school year the ability to opt in for an additional year due to the impact of COVID-19. Senate Bill 664 became law as Act 66.

HB 1335

On April 21, 2021 Representative Brian Sims and Representative Jessica Benham issued a Memorandum to members of the House of Representatives relevant to "Sexuality Education and Affirmative Sexual Consent." Such Memorandum states that "Students in Pennsylvania deserve to have a health and sexuality education that empowers them, teaches them to value their autonomy and keeps them safe. Sexuality education is vitally important, it should be comprehensive and include inclusive, accessible, science - based information with the goal of holistically supporting the health and well being of young people. HB 1335 was referred to the House Education Committee on May 5, 2021.

House Bill 1749

On May 20, 2021, Representative Rosemary Brown, posted a Memorandum to all House members relevant to Special Education Cyber/Charter School Funding. In such Memorandum, Representative Brown states "In the near future, I plan on introducing legislation which would implement the bipartisan 2013 Special Education Funding Commission's recommendation for applying the same education funding principles used to distribute state special education funding to school districts, in the calculation used to determine a school district's tuition payment for a special education student enrolled in a charter school.

House Bill 1749 was referred to the House Education Committee on July 30, 2021.

House Bill 1809 - Changed to House Bill 726

On June 22, 2021, Representative Jason Ortitay, posted a Memorandum to all House members regarding his plan to introduce a bill that creates an early literacy pilot program. Beginning in the 2021-22 school year (if enacted), the PA Department of Education will work with willing school districts to address student reading needs. This program will focus on the "science of reading" which is an evidence-based reading instructional practice that integrates listening, speaking, reading, spelling, and writing.

House Bill 726 was referred to the House Education Committee on October 5, 2021.

House Resolution 138

On August 5, 2021, Representative Karen Boback, posted a memorandum to all House members regarding her plan to introduce a resolution directing the Joint State Government Commission to study special education lawsuits in the Commonwealth. The study will examine the Office for Dispute Resolution. House Resolution 138 was referred to the House Education Committee on September 15, 2021.

Parent Liaison

- PDE added a Parent Liaison
- Each district has identified a parent(s) as part of this pilot
- Purpose:
 - Promote effective communication
 - Assist between the school district, parents, and community
 - Participate in activities
 - Collaborate with other Parent Liaisons





Lead Teacher

- Each dyslexia pilot district has one or more lead teachers
- Lead teachers participate in quarterly calls with other lead teachers in the pilot
- This is an added layer of communication to support the school district pilot team





Eligibility

Three Pilot School Districts required in legislation

- 3,000 to 15,000 student population
- Full day kindergarten program

PDE added Three Expansion Pilot School Districts: Provide opportunity for school districts under 3,000 student population to participate

 60% of school districts are under the 3,000 student population so PDE decided to extend the pilot opportunity

Goals of the Pilot

- To identify students early with reading difficulties,
- To provide an "intensive evidence-based" instructional program in conjunction with a core reading program earlier to improve overall reading skills for at risk students, and
- To reduce special education costs to school districts by providing intensive evidence based instruction.





Required Activities

- Screening 3 times per year
- Diagnostic assessment
 - Peabody Picture Vocabulary Test (PPVT) 4
 - Comprehensive Test of Phonological Processing (CTOPP)
 CTOPP2:
 - Phonological Awareness: two subtests: Blending and Elision
 - Rapid Naming: two subtests: Rapid Object Naming and Rapid Color Naming





Required Activities

- Administration of evidence-based core reading program and intervention services, including multisensory structured language programs
- Notice of eligibility for those students who can receive these intervention services
- Written parental notification for participation in the program



Required Activities (cont.)

- Parent education about dyslexia and recommended evidence-based treatments
- Methodology for evaluating effects of the Project with assistance from a nationally recognized educational evaluation institution or organization
- Annual report to the Pennsylvania Department of Education





Required Activities (cont.)

The legislation defined "intensive intervention" as

- explicit
- multisensory
- synthetic phonics instruction
- a structure language program
- delivered with fidelity by a trained interventionist
- via timely, targeted instruction with strategic re-teaching.



Core Classroom

Required Activities (cont.)

- 30 Minute Daily Lesson Implementation
- Phonemic awareness and Phonics via effective instructional practices using

Multi Sensory Structured Language (MSSL) strategies in K-2

Focus on Oral Language and Vocabulary

- Building explicit Instructional Routines
- Choosing which words to teach
- Utilizing instructional resources



Required Activities - Evaluation

School districts must fully commit to participation in all aspects of the research including:

- defined screening and assessment measures
- submission of the data on selected timelines
- training of personnel for administration of assessment and treatment protocols

Dyslexia Pilot Program: Summary



- Screening three times per year in K to 2nd grade
- Core reading program, supplemented as needed
- 30-minute core lesson using multisensory approach
- Intensive intervention beginning in Kdg
- Administration of diagnostic assessments
- Professional development for staff in assessment and multisensory structured language programs
- Parent notification to voluntarily participate
- Lead teacher(s) in each pilot site to support communication
- Participation in evaluation and data reporting



Dyslexia Pilot Extension

- As a result of the success of the pilot, the PA Legislature passed Act 37 in 2018 which extended and expanded the existing pilot.
- Pilot was extended to gather longitudinal data.

Dyslexia Pilot Expansion

 Bureau of Special Education Director, Carole Clancy lead a significant expansion of the Dyslexia Pilot

 Goal: expand the best practices learned as a result of the original dyslexia pilot to school districts in the Commonwealth who meet established criteria

- The Board is required by law to review Chapter 49 every 10 years.

- Chapter 49: September 2021
