

CAIU BOARD HIGHLIGHTS

Highlights from the Capital Area Intermediate Unit Board of Director Meeting

The following actions were taken at the **December 20, 2007** meeting.

Executive Session

- The Board discussed timeline for finalizing the CAEA/CAIU contract language for 2006-2010.
- The Board discussed personnel issues.
- ➤ The Board discussed the lawsuit filed by former CAIU bus contractors Roger Morrison and Gloria Lytle.

Reports/Updates

- ➤ The Board recognized the service of former CAIU Board members Donna Lee Clendenin, Susquenita School District, and Brad Dorrance, Derry Township School District.
- ➤ The Board was presented with highlights from the 2006-2007 Audit Report by Brown, Schultz, Sheridan and Fritz. Overall, the CAIU is in a stronger financial situation at the end of fiscal year 2006-2007 than at the end of fiscal year 2005-2006.
- Doug Rohrbaugh from Crabtree, Rohrbaugh and Associates and Alicia McDonald, Director of Student Services, presented the final design of the new school.
- Cindy Mortzfeldt, Administrative Intern and CAIU Supervisor for Aid to Non-Public School Services, shared information and floor plans associated with relocating several offices within the Summerdale Center to achieve the goals of 1) more centrally located human resources office, 2) consolidated office area for all curriculum and professional development staff, 3) improved proximity of business and administrative personnel, 4) expanded area for growth in technology, business, HR, and curriculum services, and 5) improved efficiencies to accommodate itinerant and consultative services associated with student programs and services.

- Facility Lease for new school pending final legal review by Hartman, Underhill & Brubaker. This new school will replace current leases associated with Cedar Run, Progress Ave. and Community-based Classroom. Students with severe emotional support needs, severe multiple disability needs, and dual-diagnoses of severe disability and mental illness will be served in the new school. The alternative ed and diagnostic classrooms will also be located in this school.
