# Executive Director's Report to the Board January 22, 2009

#### News

After receiving reports from the superintendent co-chairs of each of the four on-line learning subcommittees, an overwhelming majority of Superintendents' Advisory Council members indicated their desire to engage in the <u>on-line learning initiative</u> as part of our broader regional effort to redesign high schools and fulfill our vision: *Engage, Achieve, Succeed: Options for Every Learner.* Mark Hennes is currently working with the Communications and Marketing sub-committee to schedule an evening for all district board members so they can learn about this potential on-line learning opportunity.

Don Smith from the Center for Safe Schools met with a <u>newly reconstituted CAIU Safety Team</u> on January 5 to provide an orientation to all team members on developing and implementing a safety and security plan. This Team will revise current plans and procedures and ensure that all CAIU sites are included. Currently, the CAIU also conducts regular meetings of the Workplace Safety Committee, which focuses policies and practices designed to reduce our workers' compensation premiums, and the Risk Management Team, which focuses on the Capital Area Adventures program. Members from these groups are serving on the overall CAIU Safety Team to ensure a coordinated effort.

Recent news coverage of the "<u>Hill Top Puppies</u>" has created a great deal of excitement and pride among Hill Top staff and students. The new logo for the school includes a profile of the black lab mascot, one of which gave birth last month to a large litter of both black and golden lab puppies. Local ABC news anchor, Valerie Pritchett, visited Hill Top Academy to see how Scarlet and her puppies help the students deal with their emotional and mental health concerns. A story aired on Thursday, January 15, and was repeated over the weekend.

The CAIU's Capital Region Partnership for Career Development Board of Directors hosted its <u>annual</u> <u>luncheon for Superintendents</u> on January 14, with almost all superintendents participating. District students who have benefited from the work of the Partnership were on hand to share their experiences. On a related note, the Partnership director and program coordinator will be moving from HACC to the CAIU in late January. *Many thanks to HACC for providing, without charge, office space for the Partnership during the past decade.* 

#### Updates

The CAIU <u>alternative work schedule pilot</u> began this month. Curriculum Team members have commented how one clerical staff member with extended hours in exchange for one day off every two weeks has been a tremendous help in covering phones and visitors before 8:00 am and after 4:00 pm. The pilot ends on June 30 with an evaluation and decision to continue or abandon based on the results.

Negotiations with Comcast on the <u>Wide Area Network</u> are in full swing, with a deadline of January 31 for final resolution in order to meet eGrant requirements. District technology coordinators played a key role in achieving the reduction in cost and the doubling of bandwidth available for this next five-year contract with a new provider. The Technology Services Team is working with the current provider (Level 3) to ensure a smooth transition this summer. The <u>WAN Utilization Committee</u> has also met twice since being created by Dave Martin, CAIU Technology Director. This committee is comprised of both technology and curriculum specialists from our member districts and is working on maximizing the use of the WAN to provide the greatest return possible on the districts' investment in this service.

- Met with Secretary of Education Zahorchak, Deputy Secretary Harriet Dichter, and State Board Executive Director Jim Buckheit to begin collaborative effort on revisions to early childhood standards
- Met with Secretary of Education and Mayor Reed to discuss role of CAIU in working with Harrisburg School District
- Met with Dr. Dan Sheats, Susquenita SD Superintendent, to discuss a variety of concerns
- Met with PA Inspired Leadership Regional Coordinator, Dr. Mike Clemens, and PA Association of School Administrators professional development coordinator, Dr. Pat Crawford, to plan the Spring Superintendents' Leadership Conference scheduled for March 31-April 2.
- The CAIU Cabinet members met with Mechanicsburg Area School District's administrative team in the first of eight planned district visits this year to solicit feedback and input on CAIU's services. Mechanicsburg graciously hosted us to a working luncheon just before the Christmas holiday.
- Participated in a conference call with Dr. Linda Brewer, Derry Twp Superintendent, and CAIU Board Member Ellen Sheffey regarding the proposed change in health care provider
- Participated in the joint Superintendents'/Board Finanace Committee meeting to dsicuss the 2009-2010 proposed General Operating Budget.
