

CAIU BOARD HIGHLIGHTS

The following actions were taken at the **September 27, 2012** meeting held at the Enola Office of the Capital Area Intermediate Unit.

Reports/Updates

- Shawn Farr, Director of Business and Operations, shared an overview of the CAIU budgets and sources of funding.
- Theresa Kinsinger, Director of Human Resources and Communications, shared that Pennsylvania School Boards Association (PSBA) has conducted a recent salary study on behalf of the CAIU. A final report and recommendations will be shared with the Board at a subsequent Board meeting.
- Len Kapp, Supervisor of Operations and Transportation, is working with a firm to develop specifications for the Enola building HVAC system replacement.
- David Martin, Director of Technology Services, shared that Joan Adams and he have been selected to present AgendaManager at the upcoming Association of Educational Service Agency (AESA) conference in November. Also, the InfraGard Pittsburgh 2012 Safe Schools Statewide Conference will be held via videoconference with the CAIU serving as one of the four sites.
- Cindy Mortzfeldt, Assistant Executive Director, shared that she attended the annual Title I Neglected & Delinquent (N & D) Leadership Symposium. Across the Commonwealth approximately 25,000 delinquent youth are served annually through various agency programs. The CAIU provides assistance to nine privately operated institutions for delinquent youth. During the 2011-12 school year, approximately 2,500 delinquent youth received services at these institutions. In addition, the CAIU also provides the educational program at the Loysville Youth Development Center, a state operated institution.

A. RESIGNATIONS:

SHAWN FARR, Director of Business and Operations effective September 30, 2012. Reason: Accepted position at Carlisle Area School District.

Feedback about Loysville Youth Development Center (LYDC)

Former Montgomery County prosecutor and current Court of Common Pleas Judge Wendy Demchick-Alloy visited LYDC. She was very impressed with the treatment program but most important to her was the level of interaction between the staff and students. She commented that she could not believe the difference in a resident from the time she sent him to LYDC to the time he returned to the community. Thanks to the staff for your professionalism and ability to communicate exactly what we do with the kids we serve.

(The CAIU provides the educational program at the Loysville Youth Development Center. LYDC provides programming for adjudicated delinquent males. Specific programs are available to address children with serious emotional disturbance, with lower cognitive functioning, with serious substance abuse issues along with those who have more serious violent delinquent histories that require a secure environment. LYDC is funded through the Department of Public Welfare).

Supporting Districts through Monitoring

In order to support districts through the special education compliance monitoring process, the CAIU has identified a consultant who will be available for three days, free of charge, to each district on the monitoring schedule.

CAIU Partners with Messiah College to Provide Unique Classroom Experience

The Capital Area Intermediate Unit is excited to be partnering with Messiah College to offer a course to Messiah seniors who are working to become dual certified in Early Intervention (EI) and Special Education. Through this partnership, 10 Messiah students spend every Tuesday and Thursday morning in different IU classrooms, from EI to Elementary partial program (CAPP), emotional support (ES), and diagnostic classes. For six weeks, our staff will also provide one-hour seminars on Thursday afternoons on topics such as engineering the classroom for communication, behavior interventions and level systems, autism schedules and structures, Occupational Therapy (OT) and sensory integration, animal assisted therapy, and deaf/hard of hearing and vision. This partnership provides Messiah students the opportunity to work with young students in a more supportive setting than the typical classroom in a regular elementary setting.

Safe Schools

The InfraGard Pittsburgh 2012 Safe Schools Statewide Conference will be held at four sites across Pennsylvania, via interactive videoconference, on October 24, 2012. The CAIU is serving as one of the four sites. The conference will provide presentations and an interactive forum, which focuses on Anti-Bullying Awareness and Cyber Security. Presentations will be provided by: Federal Bureau of Investigation (FBI), Pennsylvania Governor's Office, Pennsylvania Department of the Auditor General, Pennsylvania Office of the Attorney General, Pennsylvania State Police, WQED Multimedia, Community Matters, Curriculum Engineers, Documentary Producers and more. *The CAIU is happy to announce that Governor Corbett, Attorney General Linda Kelly, and Corporal Thomas Tarsavage will be speaking live at the Capital Area Intermediate Unit on October 24.*
